The sterilization Law enacted in 1933 provides a lateral view for students studying the totalitarian nature of Nazi Germany Under the Nazi rule, millions of people were subjected to involuntary sterilization in the name of racial hygiene, an effort to purify the German bloodline and establish internationally their superiority as a nation
